Subject:- Affiliation of Ranjit College of Education, Gangyal for imparting instructions in regular B.Ed Course for the academic session 2003-2004.

Sir/Madam.

I am to inform you that based on the recommendations of the Inspection Committee, the Vice-Chancellor, in anticipation of the approval of the competent bodies of the University, has been pleased to authorize grant of temporary affiliation for imparting instruction in B.Ed course for the session 2003-2004 subject to the fulfilment of the conditions as detailed below.

The college has been sanctioned an intake of maximum 90 seats including 4% seats to be filled by the college management on its own from amongst any eligible candidates who may or may not have earlier applied to the University for seeking admissing to the B.Ed course for the session 2003-2004. For determining the number of 4% seats to be filled by college management, fraction below 0.5 shall be ignored. However, fraction of 0.5 and above shall be rounded off to the next higher number of seats.

#### The Management shall -

- a) appoint faculty as per the statutes (concerning eligibility, selection procedure etc.) and grant pay scales + all other allowances admissible to the teachers in the colleges of the J&K State as specified in clause (g) below.
- b) submit appointment letters and the joining reports of the faculty to the Director Colleges Development, University of Jammu.
- c) purchase books worth Rs. 1.00 lac with atleast ten different titles in each paper.
- d) arranges hostel facility for boys and girls separately and shall charge the hostel rent as specified in the Brochure.
- e) appoint a trained librarian as per qualifications laid down in the statutes and shall pay the UGC scales as specified in clause (g) below + all other allowances available to J&K State employees.
- f) adhere to 1:15 teacher-pupil ratio.
- g) the pay scales shall be as under:

Principal - 12000-420-18300 + DA + other allowances Lecturer- 8000-275-13500 + DA + other allowances Librarian - 8000-275-13500 + DA + other allowances  complete its own land and building by August 2004 to be considered for the affiliation for the next session 2004-2005, failing which the temporary affiliation granted to the college for the session 2003-2004 shall not be extended by the University.

The college may appoint 30% of superannuated teachers and all such teachers (if appointed) shall be paid the difference of the last pay drawn minus pension.

To cope up with the time lost and the academic standards, the college shall be required to hold classes during the summer vacations also.

The college shall be governed under the statutes for temporary affiliation/recognition of colleges and other institutes notified vide no. F.Acd/II/96/6601-6680 Dt.30.5.96 or those as may be notified from time to time.

In case, the aforementioned conditions are acceptable to the college, the Chairman of the College shall furnish an undertaking on a stamped paper of proper value duly attested by Magistrate 1st Class or Notary to the effect that the Trust shall fulfil and abide by all the aforementioned conditions including the achievement of targets within stipulated time.

Whereas as per statutes, temporarily affiliated colleges have to deposit the fee for renewal/extension of temporary affiliation to the University before 31<sup>st</sup> December of preceding year;

Whereas as per precedent the temporary affiliation of the college shall be extended on the basis of the inspection report submitted by the committees constituted for the purpose;

Whereas for the session 2020-21, the inspection of the colleges could not be conducted due to prevailing situation of COVID-19;

Whereas all the colleges temporarily affiliated with the University of Jammu were requested to submit an undertaking that there are no major deficiencies as per norms, and deficiency if any pending, shall be removed within two months;

Whereas the Union Government has enacted the Jammu & Kashmir Reorganisation Act, 2019, by virtue of which the erstwhile State of Jammu and Kashmir has been bifurcated into two Union Territories i.e. Union Territory of Jammu & Kashmir, and Union Territory of Ladakh;

Whereas Table-1 of the Fifth Schedule to the Act contains a list of Central Laws made applicable to the UTs of J&K and Ladakh, and one of such Acts is 'the Nationa! Council for Teacher Education Act, 1993, as mentioned at Serial No. 67 of the said table, meaning thereby that NCTE Act is applicable to the UT of J&K from the appointed day i.e. 31st Oct. 2019.

Whereas, all the colleges offering course in teacher training were requested to seek recognition from the NCTE for renewal/extension of temporary affiliation;

Whereas the Under Secretary, Ministry of Human Resource Development, Department of School Education & Literacy, Government of India vide letter dated 17<sup>th</sup> June 2020 proposed the method to grant recognition to the teacher education institutions/programmes in the UTs of Jammu & Kashmir and Ladakh from the session 2021-22 and allowed to continue the academic session 2020-21 as per past practice;
